In legalese, a cosigner is “jointly and severally liable” with the tenant, meaning that in the event the tenant

breaks the lease, the landlord can seek compensation from both the tenant and the cosigner. For example, if a tenant skips out of the rental owing two months' rent, the landlord can choose to sue the tenant or the cosigner—or both—for the full amount the tenant owes.
