A present estate is an estate that entitles the owner to possession in the present. A future estate, on the other hand, is an estate that entitles the owner to take possession sometime in the future.

Remainder = future interested created when a grantor conveys an inherently limited possessory estate and, in the same conveyance, conveys the future interest to a second GRANTEE.
