A family child care home may be classified as large or small, depending on how many children are cared for. The number of infants and toddlers that can be cared for in a family child care home is often limited. Depending on the rules in your state, family child care providers may or may not be required to be licensed. Licensed providers are required to follow a set of basic health and safety requirements.

The Americans with Disabilities Act (ADA) is a federal civil rights law that prohibits discrimination against people with disabilities. All family child care providers, including providers exempt from state regulations must comply with the ADA.
