The California Financial Code (CA Fin. Code) allows for certain exemptions from licensing by the Department of Financial Protection and Innovation (DFPI) as a Mortgage Loan Originator (MLO). These exemptions can be found in CA Fin. Code Section 22100(b) for the California Finance Law (CFL) and Section 50002.5(a) for the California Residential Mortgage Lending Act (CRMLA).

All states require a national exam for licensing. California does not require an additional state test, requires 2 hours of CA state law for those that are currently NMLS-licensed elsewhere, and requires 8 hours of continuing education (CE) annually for NMLS-licensed mortgage loan officers, 1 of which must be state law.
