Definition of Nonconforming Product: Any rejected incoming purchased product arriving from a vendor. Any part (or group of parts), subassembly or final assembly which is rejected during in-process or final inspection. Any identified issue that can be brought into compliance with minor processing and completed within 60 minutes is NOT considered nonconforming product. This clause requires an organization to establish processes to ensure that nonconforming product is identified and controlled to prevent unintended use or delivery. This is also one of the few clauses for which the standard requires the organization to develop, implement, and maintain a documented procedure.

While Clause 6.4.2, Corrective Action could apply, it does not frequently enter the process for nonconforming product unless, as an example, a nonconforming condition is severe or extremely broad (1). Corrective action for nonconforming product is normally referred to as a "disposition (2)." While this word "disposition" is not used in Q1 ...

Control of Nonconforming Outputs - OP-87-01, Rev-NC 10.3 - If an item of measuring or test equipment is determined to be out of calibration, product inspected by that item should be controlled and evaluated for potential nonconformities in accordance

Control of Nonconforming Outputs

PURPOSE:The control of Non-Conforming Material procedure is designed to ensure all materials are inspected at specific points of the process in order to identify non- conforming product. Where non-conforming material is identified the relevant corrective action is taken.

Non Conforming Product Management

When nonconforming outputs is detected, it is immediately removed from the normal process flow and one of the following people is notified: The President, Quality Manager, or Sales Manager. The product or material is removed from the normal process flow by being placed on the designated "hold shelf".
